2019 GOLF OUTING

This year the White Plains Bar Association will be holding its Annual Golf Outing at the Westchester Hills Golf Club, 401 Ridgeway, White Plains, New York, on Wednesday, May 15, 2019. All players will tee off in a “shotgun” format at 12:30 p.m. Accordingly, players should arrive well in advance of the 12:30 p.m. start to provide themselves adequate time. Men’s and women’s locker-rooms are available to all players, and Club rules require their use for all changing of shoes, spikes, etc. The Club’s Dress Code prohibits denim, cargo shorts, cargo pants and sneakers. Players are responsible for keeping their own score, and both men’s and women’s prizes will be awarded for closest to the pin, longest drive, low gross, and low Callaway net. Green fees, golf carts, lunch, prizes, use of the driving range, and your caddy’s base compensation are included in the fee. The caddy tip is the responsibility of each golfer. A luncheon ticket will be provided to each golfer, for use at the “10th Tee” either before or during the golf round. The ticket will be redeemable for a hot dog, hamburger or cheese burger plus a soft drink and chips or pretzels.

The cost for Golf is \$185.00. The cost of Golf does not include the cost of the dinner (\$85.00).

For those also attending the dinner portion of the event, a full open bar will be available from 6:00-7:00 p.m. Wine will be included with the dinner. A cash bar is available after 7:00 p.m.
